B. <u>IMPORTANT TERMS AND CONDITIONS</u>

Below are the additional conditions in addition to conditions stipulated in Bid and Service Level Agreement, General Terms and Conditions of bid and successful bidder/service provider is deemed and obliged to provide all necessary goods, services and related works within the quoted cost for successful implementation/commission of the assigned work/project under this bid:

- i. This bid is being floated for hiring of vehicles both for short term basis and monthly basis,
- ii. In respect of Cars to be hired on **Short term basis** the following points are to be agreed by the bidders:-

As far as the quantities of vehicles and number of days for which these will be hired are concerned, following points are noteworthy and agreed to by the bidder before applying for this bid:-

- (i) The number of vehicles / number of days shown in the bid document for which these will be required are tentative only,
- (ii) The actual quantities of vehicles or the number of days for which these will be required may vary upside or downside significantly,
- (iii)In case of variation in the quantities above the vehicles/ days specified in the bid document, the billing shall be done as per rates agreed after Financial evaluation for the category of vehicle which is to be hired,
- (iv) REC Limited will not be bound to pay any kind of charges more than what are agreed for in the contract as L1 rates in case the total quantities hired during the whole contract period falls below or exceeds above the quantities mentioned in the bid,

- (v) Besides the specific cars choosen (in the Bid Document) for the car categories such as Sedan, Premium Sedan, SUV, Premium SUV any other car can be demanded and shall be provided by the service provider on demand to the buyer,
- iii. In respect of Car to be hired on **Monthly basis** the following points are to agreed by the bidders:-
 - (a) The upper/maximum limits for which monthly taxi services to be provided are on the following basis-

 - (ii) 12 Hrs. daily,

(v) <u>DEPLOYMENT/ INSPECTION OF VEHICLES:-</u>

The successful bidder/service provider mandatorily needs to get the vehicle, its related papers like RC, Insurance, Pollution Certificate, Road Tax etc. and the condition of the vehicle verified and satisfactorily accepted by Admin Division, REC before its deployment. The Admin Division, REC reserves the right to carry out any such inspections during pre-deployment as well as during the entire contract period. In case of any rejection, the bidder shall provide a replacement vehicle of equivalent specification and acceptable to Admin Division, REC within 3 days of such rejection.

- (vi) All statutory obligations, including payment/labour laws/regulations/ motor vehicle Act etc must be complied by the successful bidder/service provider,
- (vii) The service provider shall not engage any sub-contractor or transfer the contract to any other person,
- (viii) The Service provider must ensure cleanliness/sanitization of vehicles regularly,
- (ix) All other taxes such as toll tax, entry tax, parking etc shall be reimbursed as per actual on the basis of documentary evidences produced,
- (x) The night charges will be applicable if taxi service timings end after 10:00 PM and commence before 05:00 A.M. on a particular day,
- (xi) Regarding night charges, vehicles selected for local journey on Gem portal as shown in the Bid Document, bidders are required to fill night charges for local journeys also irrespective of the fact that GeM portal shows "Outstation Night charges applicable,
- (xii) The duration of contract shall be 24 months further extendable by 12 months if quality of services found satisfactory,
 - (xiii) A contract / agreement shall be entered into with the successful bidder which shall incorporate all the essential terms and conditions besides those shown hereinabove and in the scope of work,
- (xiv) All other important terms & conditions have also been shown in the scope of work attached alongwith this bid,
